

General TERMS- AND CONDITIONS OF SALE for components and UVC lamps for desinfection (2020.04.22)

Terms: The individual terms of the quotation will always have priority over these General terms- and conditions

and NLM10

Delivery: Normally ex. works Holte, Denmark, if not otherwise specified in quotation.

Delivery time: Normally 2-3 weeks from receipt of firm order. To be confirmed at time of order.

Prices: The quoted prices are exclusive of value added tax (VAT) and other local taxes that are in force at the time

of delivery and are based on the currency exchange rates on the date of the quotation. The prices can be

adjusted according to the exchange rates at the time of order.

Terms of payment: Prepayment. With larger volumes a payment structure can be negotiated

Validity of: This quotation is valid for 30 days from the date of the quotation, if not otherwise specified.

Installation: Assistance for installation and start-up can be supplied. Such assistance is chargeable at the standard

hourly rates, plus necessary living and traveling expenses.

Warranty: Components are warranted for 12 months from the date of dispatch from EFSEN UV & EB TECHNOLOGY,

except for UVC bulbs and other consumable parts. Items not of EFSEN UV & EB TECHNOLOGY's manufacture are subject to the warranty offered by the original manufacturer. Any item deemed to be defective by the purchaser during the warranty period shall be returned to EFSEN UV & EB TECHNOLOGY, postage prepaid, and if judged, by EFSEN UV & EB TECHNOLOGY, to be faulty, shall be repaired or replaced and returned to the purchaser without any cost to the purchaser. The warranty specifically excludes field service. Field service will only be carried out on receipt of a valid purchase order from the purchaser. If warranty work is completed during a field service visit, then all labor charges specifically related to such work will be deducted from the total invoice, the balance of which is payable by the purchaser. All traveling time, travel and incidental expenses will be payable by the purchaser. EFSEN UV & EB TECHNOLOGY is not responsible towards customer or a third party if the equipment is used in development or production of products, which is against third parties patent rights or other types of

exclusive rights.
